NYSW BNC BY-LAWS AMENDMENT ARTICLE IX NOMINATIONS AND ELECTIONS

SECTION 1: Officers shall be elected by ballot at the chapter's annual meeting in May.

SECTION 2: Only individuals who are active members in good standing or student members in good standing and who openly and publicly support the state organization legislative platform shall be eligible for office.

SECTION 3: At a business meeting preceding the annual meeting, a nominating committee of at least two (2) members shall be elected. The immediate past chapter president shall serve as chair of the committee. The nominating committee shall present a slate of one or more nominees for each office to the membership at least one month prior to the annual meeting. Nominations may also be made from the floor at the meeting one month prior to the annual meeting. Thereafter nominations shall be closed.

SECTION 4: Vacancies in office shall be handled as follows:

(a) In the event of death, resignation, or incapacity of the President, the President-Elect shall become president for the un-expired term.(b) Vacancies in offices other than president shall be filled for the unexpired term by the executive committee.

SECTION 5: A plurality of all votes cast for a given office shall constitute an election.




